2023/24 Vital Impact Fund (Ref: 60/30)

A report from the Grants Manager dated 5 December 2023 was circulated. An Appendix to the report was circulated separately.

The Grants Manager gave some background on the work to-date with regard to the Vital Impact (VI) 2023/24 allocation, highlighting the recent workshop and research commissioned by the Trust, and outlining the options presented in the report. He indicated his strong preference for Option 1 in the report, which is to continue the current process and support the most disadvantaged through a Housing focus, which aligns with Trust Strategy, and takes into consideration feedback from the community and those working in the social housing space.



The Chief Executive Officer (CEO) explained the rationale behind the second option in the report, which adds the current budget to the amount proposed for the next Financial Year, allowing for the exploration of collaborative opportunities with the Company and Capital Beneficiaries, and an extended timeframe in which to utilise the Fund.

Trustee West pointed out that identified projects could potentially be funded from both the current and subsequent Financial Year separately, thus providing a chance to see some results from the first year's funding.

Trustee Silverton shared his preference, given the direction offered by the research and the high need in the community, to continue with the current process, aiming for as broad an impact as possible with the projects selected.

It was clarified that the Distributions budget being considered at this stage was as per the draft Annual Plan presented to the November Trust meeting.

Trustee Chew expressed his preference to utilise the 2023-24 VI budget in the current year, unless increased funds and a wider impact could be realised.

The Grants Manager raised his concern about shifting to a different focus, and he reemphasised the growing demand on social services.

The CEO restated that there were two distinct options on the table, and the main reason for this was to drive a timely decision.

Trustee Johnston relayed that her preference was to distribute the VI Fund sooner rather than later, and that she would welcome any external guidance to ensure it is well-spent.

Trustee Strange agreed with the view that the Fund should be spent in the current Financial Year.

Trustee Afeaki raised the prospect of working closely with the Company via Option 2, which the Company had showed support for. She gave assurance that the suggested focus would not be forgotten.

Trustees voted by majority for Option 1 as the preferred recommendation.
